2013 Georgia Simulated Emergency Test (SET) (September 18, 2013 Version)

Background: The 2013 Georgia Simulated Emergency Test (SET), to be held on October 5th, 2013, will be somewhat different from SETs we've done the past few years. This year, we will be using any and all resources available on the day of the SET. In other words, if it works, use it.

As ARES members, we need to be proficient in areas we are traditionally called upon to support in times of disaster. This is normally passing health and welfare traffic in the format of the ARRL Radiogram. We also need to look to the future. If we are going to be valuable assets to EMAs, we need to be proficient using the ICS message forms and understand what is required to properly fill them out.

How we get the message through depends on the type of message and what we have available. The bottom line is still to efficiently and accurately pass the desired message from the sender to the recipient.

Pre-SET Preparation: Prior to the SET, the local EC will conduct a review of NIMS structure and terminology with their ARES group. The training will include a review of ICS-100 and ICS forms commonly used to support and document an incident. This would be an excellent time to involve the local EMA. Invite him/her to your meeting to meet your members and help facilitate the discussion. The EC will also review ARRL radiogram procedures to include proper handling of traffic and how to fill out the form.

The SET: The GAARES net will be called into session at 0900 with the usual check-ins on the frequencies being used for the SET. The SET will begin at 1000 and consist of four different drill messages sent by the Section. The messages are sent at different times during the SET to better allow anyone wanting them to copy them a chance to do so. See the schedule below for exact times the messages will be sent.

The messages will be transmitted over D-Star, Reflector 30B; CW, 3.549 MHz; SSB, 3.975 MHz LSB; and BPSK125 on 3.583 USB +1000 Hz and 7.065 USB +1000Hz. Time permitting; the digital message will be retransmitted using Olivia. Each message will be repeated several times over a 15 minute period. The EC will be responsible for assigning stations to copy the messages.

At the end of the drill, the EC will review and consolidate the messages into an email which will be sent to the SEC (ke4fgf@winlink.org) and the regional DEC preferably by Winlink. The email will include a copy of each message and a summary of the different methods used to receive each message.

In order to integrate Technician Class licensees into this drill, the EC or his/her designee should consider retransmitting the messages over local repeaters. Both FM voice and PSK can be successfully transmitted over analog repeaters.

Ground Rules: All FCC rules apply. All communication will include words to the effect that the message is a drill only and does not represent anything real or actually happening.
